IMPORTANT : Le paragraphe 1(5) du Règl. de l'Ont. 63/09 pris en application de la *Loi sur les pesticides* inclut une référence à l'écriteau A, B, C, D, E, F ou G. Ces écriteaux sont illustrés dans les pages qui suivent. L'apparence des écriteaux doit être la même que ceux illustrés ci-dessous pour que les écriteaux soient estimés conformes au Règl. de l'Ont. 63/09. **Remarque** : Le Règl. de l'Ont. 279/09 modifie le Règl. de l'Ont. 63/09 en remplaçant les écriteaux provisoires C, E et G, qui avaient été affichés sur le présent site Web. Par ailleurs, bien qu'une illustration d'un écriteau ci-dessous comprenne la date de la version de l'illustration, il n'est pas nécessaire que cette date figure sur l'écriteau.

Other items shown to be printed in capital **black** letters 1 cm high (minimum). Information to be entered next to each item, printed in capital letters or numbers that are 1 cm high (minimum). See Table in s. 59.

The words "DO NOT ENTER" to be printed in **red** capital letters, 7 cm high (minimum).

The words "DO NOT REMOVE THIS SIGN UNTIL AIRING OUT IS COMPLETE" to be printed in **black** capital letters 2 cm high (minimum).

The words "PESTICIDE USE" to be in capital red letters 2.5 cm high (minimum)

Capital black letters 1 cm high (minimum) and information to be printed in capital letters or numbers 1 cm high (minimum)

Words and markings that identify the employer of the person performing the land extermination or that identify the owner/ occupier or person in charge and that do not detract from the required information; not to occupy more than bottom 2.5 cm of the sign

Words or markings that identify the employer of the person performing the land extermination or that identify the owner, occupier or person in charge and that do not detract from the sign; not to occupy more than bottom 5 cm of the sign

Black single silhouette of an adult person on white background. **Red circle** (outer edge a minimum of 21.5 cm in diameter and width one tenth of the diameter) and oblique **red bar**

The words "PESTICIDE USE" to be in capital red letters 5 cm high (minimum)

Capital **black** letters 1.5 cm high (minimum) and information provided in capital letters or numbers 1.5 cm high (minimum)

Words or markings that identify the employer of the person performing the land extermination or that identify the owner/ occupier or person in charge and that do not detract from the sign; not to occupy more than bottom 5 cm of the sign

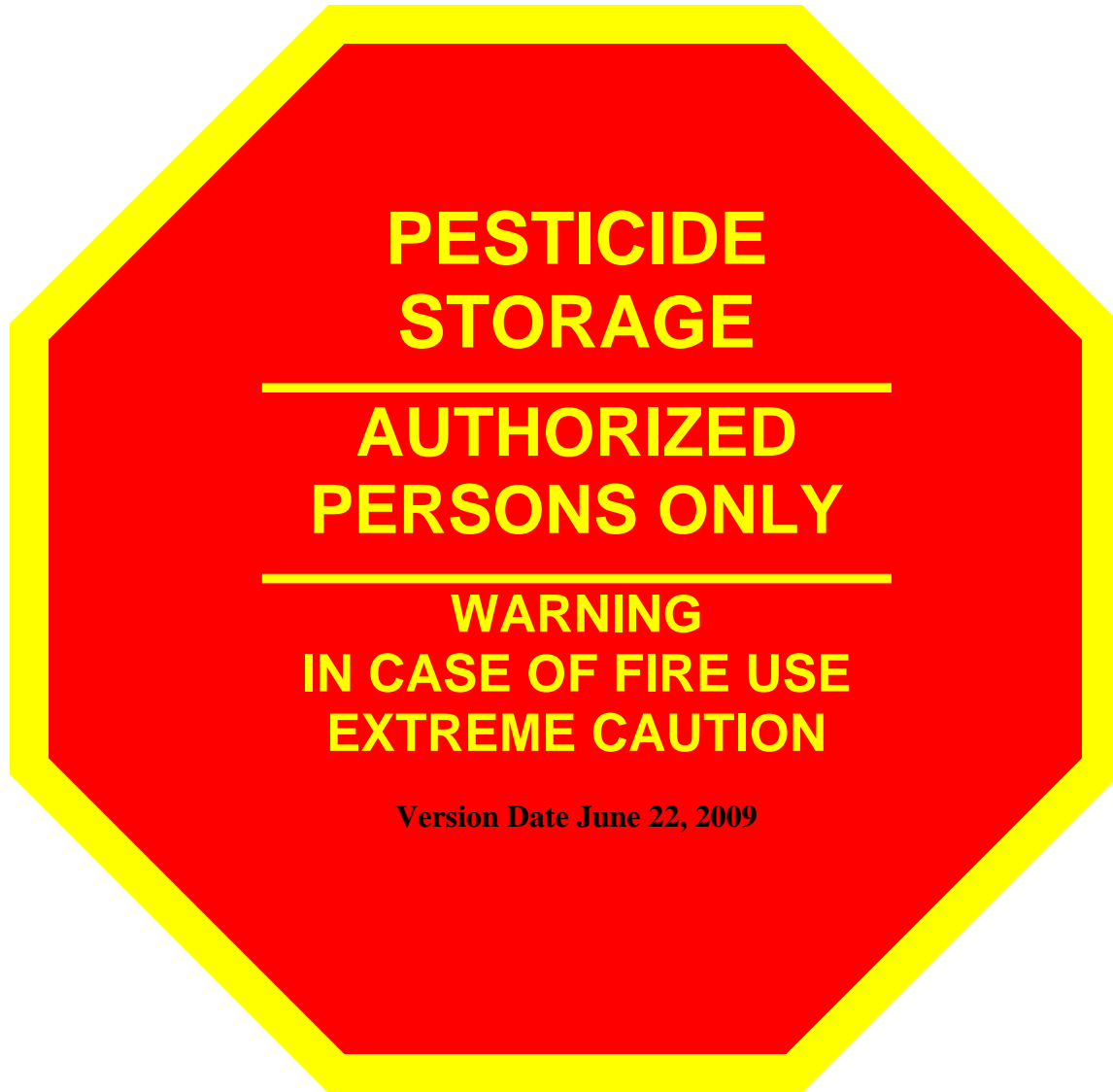

The words "**CHEMICAL STORAGE**" can be substituted for **PESTICIDE STORAGE** in accordance with subs. 108 (4) and subs. 109 (3), of the Regulation

Octagonal sign with red background

With or without a white or yellow border

With or without a logo on the top and other identification markings on the bottom of the sign

With black, white or yellow horizontal lines separating text

Capital black, yellow or white letters

Version date not required to be printed on sign
